# Agreement between Occupational Safety and Health Department and Health Facilities in Providing Worker/Employee Checkup Services

## Minister of Labour and Vocational Training

- Having seen the Constitution of the Kingdom of Cambodia
- Having seen Royal Decree NS/RKT/0918/925 dated 06 September 2018 on Appointment of Royal Government of Cambodia
- Having seen Royal Decree NS/RKT/0320/421 dated 30 March 2020 on Appointment and Adjustment to the Composition of the Royal Government of Cambodia
- Having seen Royal Code NS/RKM/0618/012 dated 28 June 2018 promulgating the Law on Organization and Functioning of the Council of Ministers
- Having seen Royal Code NS/RKM/0105/003 dated 17 January 2005 promulgating the Law on Establishment of Ministry of Labour and Vocational Training
- Having seen Sub-decree 283 OrNKr.BK dated 14 November 2014 on Organization and Functioning of the Ministry of Labour and Vocational Training
- According to Prakas 429/20K.B/Br.K.Kh.L dated 31 December 2020 on Cambodian Worker/Employee Checkup
- According to the necessity of the Ministry of Labour and Vocational Training;

## Decide

#### Article 1

The purpose of this Prakas is to determine formalities and procedures for signing an agreement between the Occupational Safety and Health Department and health facilities in providing Cambodian worker/employee checkup services.

## Article 2

Any health facilities wishing to provide Cambodian workers/employees with checkup services shall meet the following requirements:

- Sign an agreement with the Occupational Safety and Health Department of the Ministry of Labour and Vocational Training in accordance with the agreement format stipulated in Annex 1 of this Prakas.
- Have a license recognized by the Ministry of Health and pass the assessment with regard to the provision of services and service quality from the Occupational Safety and Health Department.
- Have a proper location, status and appropriate and adequate infrastructure for providing checkup services in a quality manner in accordance with the requirements set by the Occupational Safety and Health Department including:
  - Proper and hygienic environment

- Medical equipment, materials and tools and other necessary standard means for supporting the checkup.
- The health staff have technical capacity, morality and proper number as required by the Ministry of Health.

#### Article 3

The Occupational Safety and Health Department shall monitor the quality of the checkup services of partner health facilities by cooperating in regularly providing each other with information to promote service quality and guide the use of the services in an effective manner.

#### Article 4

The Occupational Safety and Health Department and partner health facilities can review and renew their agreement based on the service quality and level of service provision of partner health facilities. The Occupational Safety and Health Department has the right to cancel the agreement with any partner health facilities that fail to comply with the requirements and regulations.

#### Article 5

Any regulation contrary to this Prakas shall be abrogated.

#### Article 6

Cabinet Chief, Director General of General Department of Administration and Finance, Director General of General Department of Labour, Director of Occupational Safety and Health Department, Director of Labour Inspection Department, Director of Municipal Provincial Department of Labour and Vocational Training and directors of all relevant units under the supervision of the Ministry of Labour and Vocational Training shall be in charge of implementing this Prakas as per their respective duties from the date of signature.
