Decide

Article 1

The purpose of this Prakas is to launch public services related to the labour and vocational training sector via automation system to promote the quality, effectiveness, transparency and accountability as well as to respond to the request of the private sector in the Industrial Relations Working Group of the Government-Private Sector Forum.

Article 2

The public services related to the labour and vocational training sector shall be launched via automation system from 11 January 2021 for public services that are under the scope of the central STREET BERRY level of the Ministry of Labour and Vocational as follows:

In addition, public services that are under the scope of Provincial Departments of Labour and Vocational Training and Municipal/Provincial Single-Window Unit will be launched from 01 March 2021.

Article 3

Any regulation contrary to this Prakas shall be abrogated.

Article 4

Cabinet Chief, Director General of General Department of Administration and Friance, Director General of General Department of Labour, Director General of General Department of Technical and Vocational Education and Training and Directors of Municipal/Provincial Department of Labour and Vocational Training shall implement this Prakas as per their respective duties from the date of signature.
